

## Dear Hunter:

We are pleased that you are participating in the 2022 hunt at the Rappahannock River Valley National Wildlife Refuge (Refuge). Enclosed is your hunt permit (if required) and a unit map. In 2021, we finalized a new Hunt Plan (available on our website).

As per our new Hunt Plan, the following changes were implemented during the fall of 2021:

- Archery hunting on Wright, Franklin, and Mothershead units no longer require permits. Hunters are required to check in with RecAccess.
- Coyote, turkey, and small game hunting are now available on the Refuge
- Turkey and small game hunting require non-lead shot.
- All hunting activities on the Refuge will require non-lead shot by 2026 or earlier.

Changes for 2022 (Please see **Table 2** for hunting opportunities and dates).

- A limited spring gobbler hunt was offered at the Refuge for the first time in April (Franklin, Mothershead, Toby's Point, Wright, and Thomas (Thomas is archery only)).
- Waterfowl (mid and late season) will be offered in December and January 2022-2023.

**PARKING:** Hunters must park in designated parking locations as indicated on Refuge hunt map. These designated parking areas include gravel roads on units that do not have designated parking areas and hunters must be parked in a manner to allow passage by other vehicles along roads and through gates. ATVs/UTVs and trailers are prohibited. While hunting on units that require a permit, hunters must carry a hunting permit and display a parking permit.

**SCOUTING:** Scouting is permitted from 8:00 AM until 4:30 PM on the dates listed below.

**HUNTER ETHICS:** Please respect the land and other hunters by following these simple rules:

- We require stand hunting only. Stand hunting includes the use of portable hunting blinds, portable tree stands or stationary ground hunting. No deer drives, stalking, or roaming are allowed.
- No damage to trees. No nails, screws, bolts, or screw-in steps may be used. Stands and blinds must be removed daily.
- No cameras, nor other photographic or electronic recording devices are permitted.
- We prohibit the use of flagging to mark trails or for any other purpose.
- Be considerate of other hunters; do not intrude in their space and minimize vehicle use.
- Take all your trash with you, including food wrappers and spent shells.
- If you witness violations or experience problems, please report them immediately to the Refuge office at (804) 333-1470.

Refuge units will be open no earlier than one hour before legal shooting hours to one hour past legal sunset for permitted hunters or those who have used the online check-in system (depending on the unit) on designated hunt dates.
