
#### Age-0 Smolts for the Yankee Fork

Sawtooth staff transferred 221,616 eyed eggs to Irrigon Fish hatchery on October 25, 2023. These eggs are part of a trial to compare egg boxes, Age-0 smolts (50 fpp) and Age-1 smolts (18 fpp) in the Yankee Fork of the Salmon River. Acclimation of the Age-0 smolts will occur in May of 2024.

The goal of this trial is to examine if Spring Chinook reared in a Fall Chinook life history strategy - i.e. spring outmigration as Age-0 smolts will produce measurable adult returns. Similar work has been tried off and on over the past four decades with mixed results.

Specific challenges for this group include water hardness differences of 79 ppm CaCO3 in the Yankee Fork and 240 ppm at Irrigon. Umatilla hatchery has released spring Chinook in the Grande Ronde river with some success at a similar water hardness (69 ppm).

If this pilot is successful at migrating smolts at a similar rate to Sawtooth reared Age-1 smolts, additional work or releases may be considered.







#### Follow-up on Grande Ronde Habitat Projects

LSRCP, NOAA, ODFW, CTUIR, and USFS staff met at the Grande Ronde river to look at ongoing habitat work and beaver re-colonization. These projects have done a great job at reconnecting the flood plain and encouraging beaver activity in the area. The long-term benefits aren't yet entirely clear, but the short-term side effects do appear to be lower availability of spring Chinook spawning habitat in areas that historically had 40% or more of the surveyed redds. Discussions amongst the parties are still working on formulating shared objectives.

Additional work is slated for the summer of 2024 that will put additional channel spawning structures and log woody debris in the area just below the LSRCP acclimation ponds. Much of this work is completed with heavy equipment and helicopters to place the large woody debris. The next phase will occur primarily on private land where redd survey work has not been allowed. Hence, immediate effects of the projects may be difficult to assess.

HABITAT WORK IN UPPER GRANDE RONDE




#### **Clearwater Pipeline Assessment**

Engineer work started this Fall to assess the Clearwater pipeline and how it can be permanently repaired. Overall, the initial assessment showed the pipeline to be in good shape. Exposed sections of the pipe do need a new coat of paint and the majority of the manual air relief valves are packed with dirt, etc.

A final engineer assessment and plans for repair will be complete by December 2023 for the May 2024 work-window.


### TRUCK WRAPS

#### Greg Burak, LSRCP Permit Coordinator

I joined the US Fish and Wildlife Service in November 2009 as a fish and wildlife biologist working with the Idaho Fish and Wildlife Office on various sections of the Endangered Species Act to carry out listed species conservation in Idaho. This work has included classification, recovery, consultations, and candidate conservation, along with being IFWO lead for multiple partners for fish and wildlife projects. One of my primary tasks over the last several years was coordinating the competitive IFWO recovery and candidate funding program where we provided over \$2.5 million in financial assistance to our partners to carry out priority conservation work for listed and at-risk species.

Prior to the USFWS, I worked for the Idaho Department of Fish and Game from 2001 through 2009 ranging from a wildlife technician to a regional wildlife biologist. In addition, I worked several field seasons for the US Forest Service Rocky Mountain Research station where I monitored and mapped threatened Chinook salmon spawning habitat in the Middle Fork Salmon River drainage of central Idaho and carried out research investigating the efficiency of various methods for monitoring bull trout.

Originally from northeastern Pennsylvania, I graduated from Penn State University with a Bachelor of Science degree. After moving to Idaho in the late 1990's, I obtained a Master of Science degree from Boise State University in 2006. Off the job I enjoy spending time with my wonderful wife and 2 daughters (12 and 16 years old) and visiting Idaho's abundant public lands through avenues such as fly fishing, upland bird hunting, hiking, backpacking, camping, and mountain biking.
