National Workplan to Address Downlisting and Delisting Recommendations 3-Year Workplan (September 2022)

Key to Terms:

Proposed rule – Publication in the Federal Register of our proposal to change the status of a species, along with the rationale for the proposed action and a request for any relevant new information and public review

Final Determination – For species that have already been proposed for downlisting or delisting, publication of our final determination in the Federal Register. We will either finalize or withdraw the proposed rule

12-month finding – Upon receipt of a petition containing substantial information to delist or downlist a species, we conduct a status review and publish a finding on whether the petitioned action is warranted. If we determine the action is warranted, we generally intend to proceed with a concurrent proposed rule. If the action is not warranted, we will take no further action.

Downlist to T – Reclassification of the species from an endangered species to a threatened species, marking an improvement in its status.

Delist due to recovery – Removal of a species from the List because the species is recovered and no longer meets the definitions of either an endangered species or a threatened species.

Delist due to extinction – Removal of a species from the List because a sufficient period of time has passed since the species was last detected and the best available information indicates the species has a very high likelihood of being extinct.

Revision of entity - We have new taxonomic information regarding the species and will incorporate that new information into our rulemaking.
