Hi Matt: The coop agreement option is not applicable to your situation. The disposal authority referenced by CRS and cited in 16 U.S.C. §§668dd(a)(6)(B)(iii) applies only to other agency lands that FWS is currently managing pursuant to a cooperative agreement. If the terms of the cooperative agreement provide for termination of the agreement (say, with an expiration date), then we may dispose or relinquish our management under that agreement. This routinely occurs where we have expiring management agreements with states to manage state lands. This authority does not allow us to dispose federal NWRS land where the FWS has primary management responsibility.

Although we cannot transfer this site to the local municipality short of Congressional/MBCC approval or an equal value land exchange, there might be an opportunity to enter into an agreement with the local municipality that would allow them to use the site. That could be something to discuss with IMD.

Hi Matt: The cooperative agreement angle is new to me. The available means for disposal of NWR lands are: (1) an act of Congress, (2) exchange, or (3) via MBCC approval once the Secretary determines the lands are no longer needed. Under #3, fair market value for the property must be deposited in the MBCF. Regarding the pink house, I'd question whether the lands really are no longer needed. I assume if it weren't for the structure, we'd still want the lands for their habitat value.

Hi Mark,

There is a public forum tomorrow in which I will be asked questions about "disposing of" OR exchanging Parker River's old HQ (north tip of Plum Island) potentially with lands owned by the City of Newburyport, for their future use for emergency services on Plum Island. We no longer have a need for this land and have asked the city if they want to pursue an exchange for some time.

In advance of the forum I've been doing some research and found the below from [this document](#) (pg 9):

For acquired lands, the National Wildlife Refuge System Administration Act provides certain limited authorities to dispose of lands within the NWRs. FWS may dispose of such lands only if (1) the disposal is part of an authorized land exchange (16 U.S.C. §§668dd(a)(6) and (b)(3)); (2) the disposal is pursuant to a cooperative agreement with a state or local government (16 U.S.C. §668dd(a)(6)); or (3) the Secretary determines the lands are no longer needed for the NWRs's purposes and the Migratory Bird Conservation Commission approves the disposal (16 U.S.C. §668dd(a)(5)).

Obviously, our preference is for an exchange, but I am skeptical as to whether Newburyport has any suitable lands for us. So, have we ever pursued options 2 or 3, above? And, for the Pink House, is option 3 an option? Can it be?!
