Hi Matt,

Thinking about the question raised about about granting the preservation restriction, I wondered whether the STPH wouldn't be able to serve that role. Since we may likely be providing them an equalization payment depending on the appraisal results, it sounded as though they are the actual entity that we are exchanging the property with, and then they would transfer it to the new 'owner' or 'steward'.

The timing issue sounded as though it could be an issue for them, but it seems like it could more easily be sorted out between them and the new owner than with the government.

I must be missing something, right? It can't be just that simple.

Just a quick update -- the meeting Wednesday went well and STPH did not bristle at any of the restrictions, in fact they welcomed most. There was slight concern about a future owner not even being able to construct a small outdoor shed or something of the like. They are now in the process of taking this info back to their full board and I expect to have their official opinion in short order.

Here were some questions that arose:

- They asked how to pay for the required steps. I stated that, while we manage the SOW/contracts, I believe STPH would pay those contractors directly, is that accurate?
- They asked again about time frame (for appraisal). I mentioned again likely 6-9 mos.
- Could STPH be there in-person for the appraisal?
- If an equalization payment was made from us to STPH, how would that work? I stated it would likely be deposited directly into the group's account, but that I would check on this.
- They asked to walk through the house again (along with the future prospective owner). I stated it's a reasonable request but all our facilities are currently closed to non-staff due to COVID.
- They want to place a preservation restriction on the house now, prior to transfer, with USFWS as the Grantor. I stated that any such restriction could not take place while USFWS maintains ownership.
