Attached are notes from the call this week -- Lauri, thanks for being there, and I'd appreciate it if you could review these to make sure I accurately captured what we discussed.

Just an FYI for you both, I have another (in-person) meeting today and the same players will be represented. Most of today's meeting will focus on the Merrimack River dredging project (and the need for add'l permitting & plover monitors into April due to an unforeseen project extension), but at the tail end of the meeting we will discuss the possibility of exchanging our old headquarters facility with the city of Newburyport. The old HQ, on the north tip of Plum Island, is an eyesore and not something we have any use for; the city and congressionals are interested in using that space for future emergency services sub-station. I expect this will come up with congressionals more as we proceed along that path.
