Hi Mark and Bill,

The public forum today went well -- and it was mostly civil, which I'm grateful for!

The attached map --created during Bill Peterson's time here -- is what I've been using as a rough guide to search within the 1-mile radius of PKR boundaries for potential acquisitions. A question came up during today's forum about lands across the river to the North in Salisbury, which is outside of that 1-mile radius. However, IF the old keeper's house on Plum Island counts toward that 1-mile radius, then there would be a sliver of less than 100 acres that may fall within that radius.

Do isolated "outholdings" (is that a word?) like the old keeper's house get the same 1-mile radius? According to this map, they do not. But want to make sure all bases are covered.
