I hope you are well and have been staying safe during this unprecedented year.

I am reaching out to see if we can have a quick conversation about the Initial Proffered Permit for the Tribe's oyster farm that was sent out by USACE last week. There are a couple of Special Conditions that require further coordination with U.S. Fish and Wildlife Service. One being the status of the compatibility determination per our August 2020 correspondence, and the other to develop a monitoring plan in coordination with USFWS.
