In general, the USFWS has a positive relationship with Congressman Kilmer's office. In the past several months, Congressman Kilmer's office has had several topics of engagement with the USFWS in his District.

**Correspondence regarding on going-Navy consultations -**

Cong. Kilmer sent a March 27th letter to the Service requesting information on our interactions with the Navy under ESA Section 7 consultations and other authorities. *We are currently drafting a response, which will be forwarded to DOI for review per guidance.* We have a positive working relationship with the Navy and good information exchanges during the consultation process.

**Hatchery Genetic Management Plans (HGMPs) -**

Congressman Kilmer has expressed concern about the completion of hatchery genetic management plans and the limited staffing resources of the Service. In the Pacific Northwest, where hatchery genetic management planning is an issue, the National Marine Fisheries Service (NMFS) is the lead agency responsible for consultation under section 7 of the ESA,

and is responsible for approval of hatchery genetic management plans (HGMPs). Working with the Service and the Washington Department of Fish and Wildlife, NMFS developed a shared consultation timeline to complete all Puget Sound hatchery program consultations by the fall of 2018. *The Service's Washington Fish and Wildlife Office is increasing its consultation capacity and has fully committed one staff member to Puget Sound Hatchery consultations.* ( For more information, see **2017 Budget Effects statement re: References: House Report 114–632, pg 14.**)

**Nisqually National Wildlife Refuge re-naming-** Congressman Kilmer introduced legislation to rename the Nisqually National Wildlife Refuge to honor Native American civil rights leader Billy Frank Jr. *The Billy Frank Jr Nisqually National Wildlife Refuge was renamed on July 19, 2016 with several Members of Congress and tribal representatives in attendance.* In addition, Cong Kilmer was responsible for legislating the Medicine Creek Treaty National Memorial on the Refuge. Medicine Creek was the location in which tribes signed the 1854 treaty with the US government.

**Shellfish aquaculture-** Reps. Kilmer requested from the Army Corps to receive updates from the Seattle District, the NW Division, and Corps Head Quarters on steps they've taken to address some ongoing challenges around shellfish aquaculture permitting and the process moving forward under the 2017 Nation Wide Permit. *FWS attended at the request of the Congressman as part of the Federal agency representation, although the issue does not lie within our jurisdiction.*

**Puget Sound Partnership- WFWO? help, pls** - In Oct, 2016, Congressman Kilmer, along with many other elected officials and Members of Congress announced [new federal actions](#) to help protect and recover the health of Puget Sound, one of the nation's largest estuaries. These actions were intended to reflect a commitment from the federal government to help restore Puget Sound, and are similar to federal actions taken in recent years to protect other large aquatic ecosystems, such as the Chesapeake Bay and the Great Lakes. The FWS is a member of the Puget Sound partnership and engages with the Congressman in this context although we have not provided significant amounts of funding towards the effort. <https://obamawhitehouse.archives.gov/blog/2016/10/18/taking-action-protect-puget-sound-watershed>
