thanks Robyn. Very happy Frank gets to play an expanded role in this as he has had background involvement since the beginning.

This is a different action than getting a lease for a shellfish farm on state lands where we don't control the lease. The action (aka proposed use) would be to access the refuge (ie beaches) to conduct aquaculture debris clean up activities per their section 7 requirements. Under the NWRSIA they would need some type of refuge specific approval (ie special use permit being the normal mechanism), this would then lead us to the requirement for determining if that use (Marine debris cleanup in a closed area) is an appropriate use and is then compatible with the purposes of the refuge and the mission of the NWRS. Also need NEPA, Sec 7, NHPA etc... Many of the other environmental requirements may be met by adopting the Army Corps compliance docs. Compatibility determinations are on us.

Jennifer is prepared to work with the tribe and figure out how to get to yes (if at all possible). She will do a CD and follow our public comment process.
