Good Morning, Robyn and Hugh-

Per your request, please find below a very brief update on the current status of work from ES. We coordinated with Refugees on this issue.

- WFWO completed a formal consultation through an existing Shellfish

Aquaculture Programmatic. A letter was sent to the Corps of Engineers on 10/20/2020 documenting consistency with the Programmatic Biological Opinion. That concluded our formal consultation with the Corps on the Jamestown S'Klallam Tribe's action.

- ACOE has not issued a FONSI or permit; if they do issue the permit then the Tribe would need to work through state DNR on leasing and create disturbance monitoring protocols that are acceptable to the refuge.
- Recent litigation brought by the Center for Food Safety against the ACOE will likely impact the use of Nationwide Permit 48 for oyster culture activities in the Puget Sound area.
