Thank you for the response. Moffat County has examples of past cooperating agency agreements we have signed with BLM and I would be happy to share that if it is useful.

It might be similar to a USFWS agreement since they are both DOI agencies. I have been representing Moffat County in cooperating agency meetings for over 20 years and would be happy to speak with you about how our input could be incorporated and still keep a fast-paced efficient 10J process moving forward if you would like to give me a call, I'm happy to discuss.

Moffat County is used to providing useful input early and up front, and immediately we would like to provide input on the scoping Notice of Intent and assist in evaluating scoping comments in partnership with USFWS.

It would be most helpful to schedule a cooperating agency meeting simply to discuss the process moving forward, including signing an agreement, as soon as possible. Would you be available this week or next for a discussion?
