Thanks for the clarification. It actually helps understand everything better. Navajo Nation is in Region 2 of the FWS, and our Region does things a bit differently than R6 (Colorado). We just had no clue this work was going to be contracted out (no fault of your own/contractor), so this really helps to understand the correspondence send to the Nation.

Thanks for providing clarity and helping us to respond to Navajo Nation. I'll reach back out to Gloria Tom at Navajo Nation and explain what's going on to her. I think their issue is just ensuring that consultation is occurring with USFWS and not a third-party, which by what you providing is what is happening. Can you confirm that USFWS will actually be present and leading the introductory consultation meeting?

Hi Westley,

Chronicle Heritage (formerly PaleoWest) is the subcontractor for WSP, who is USFWS's contractor

for the CO Wolves 10(j) Rule Development project. I've attached the USFWS's SOW to this email. WSP is contracted for environmental consultation work, and Chronicle Heritage is contracted for assisting with the draft EIS (cultural and Tribal information sections) and Task 4 (Section 106 and Tribal Consultation). We completed our DEIS task. We were told by USFWS (Nicole Alt) that Section 106 (Task 4a) consultation was no longer needed. We are currently working on Task 4b (Tribal Consultation) and have been working with USFWS on that for the past several months.

I've cc'd WSP on this email, in case they can provide additional context.

Nicole Alt, Liisa's predecessor on this project, tasked Chronicle Heritage with coordinating Tribal consultation meetings between interested Tribes and the USFWS. We reach out to the Tribes to schedule the meetings, create the meeting invitations, take notes during the meeting, and distribute the meeting minutes to the USFWS and the Tribes. We then will prepare a final report for USFWS summarizing the consultation efforts, and we help prepare consultation letters when requested. We were requested by WSP, on behalf of USFWS, to send the correspondence that I sent to Navajo Nation.

I will be away from my computer most of the day today preparing for a field project, but please feel free to call 724-961-3789 if you would like to discuss anything in more detail.

If USFWS has adjusted guidance for WSP and Chronicle Heritage on what our tasks as contractors are, please let us know, as I am still operating with the SOW and guidance provided by Nicole Alt.
