It is all based on the schedule – see the snip-it below.

As you and I just discussed on the phone, if it is the desire to move up the cooperating agency review, we can move this schedule up but would require your review to move up to COB 7/7 – which is a fast turn around given it is a holiday week. Then we would take our 8 days and turn it to 5 days and get the next version to you by 7/14. I am assuming we can do this because the bulk of the new text to review is the comment response report. You will get the next version of that Tuesday, June 20. If you can review that and turn it back to us by 6/30 – we can work on those edits while you are reviewing the FEIS/ROD/NOA. The changes to the FEIS should be pretty minimal, focusing on incorporating the ungulate provision changes and the changes to the socioeconomic analysis we discussed on the last call.

Also for the schedule you asked that lines 63 and 65 are:

- Line 63 is the time WSP will take to incorporate any changes/comments that the Services has on the first admin draft FEIS/ROD/NOA.
- Line 65 – we can talk about when this best fits with the revised schedule but the intent here is that after we get cooperating agency meeting comments, we will need to meet to resolve them. Not sure where everyone is located but we could do this in person in the greater Denver area or a few hour Teams meeting.

Good Morning All,


Hope you all have had a good week and have some fun plans for the holiday weekend.
