I am reaching out to request a Stage 3 FEIS briefing for the DRT for the Final Environmental Impact Statement to for the final issuance of a rule to an establish an experimental population of the northern gray wolf in Colorado under the Endangered Species Act. As noted in the attached briefing paper, the State has requested this action and completion by December 31, 2023, to comply with Colorado state law. The Service and the Department have agreed to support the state reintroduction and meet their timeline, if possible. It is our hope that we can schedule the DRT by/before September 1<sup>st</sup> to meet the above timeline.
