Dennis:

Great speaking with you yesterday about the possibility of Wildlife Services coordinating/advising on gull hazing with the three partners involved in the Farallon mouse eradication project (USFWS Refuges, PRBO, and Island Conservation). We really appreciated you loaning Derek to us in January to assist in the first mini-trial. We learned a lot in a very short period.

As promised, attached is a **Draft** Report of the 5-day January gull hazing trial conducted on the Farallon Islands by my assistant Maddie Pott, Derek Milsaps and Winston Vickers. While it is still in draft form and **not for distribution** yet, it will give you an idea of how much research has been done so far on what tools and techniques and man-power are being considered for conducting a coordinated gull hazing effort on the island during the late fall of 2012, when the eradication is planned for. We have not whittled down which techniques will definitively be used or not, but the most effective techniques do stand out.

The USFWS and IC are currently rebudgeting the project for the new EIS timeframe, and this allows us some time to both develop a more complete and detailed Gull Hazing Plan and to conduct any additional (extended) gull hazing trials, likely this fall, in November 2011.

In the event that some arrangement can be scheduled/planned for with enough notice, we would appreciate it if you could provide a basic preliminary cost estimate in dollars for the following distinct services:

1. Review and revise/comment on the current **Draft Hazing Trip Report** (20 hours?)
2. Write a **Draft Gull Hazing Plan** in coordination with USFWS, IC and PRBO (By August 2011)
3. Conduct a **limited 2-week field trial** of the Draft Gull Hazing Plan on the Farallones in early November 2011
4. Write a brief **Trial Report** and **revise the Gull Hazing Plan** based on trial results
5. **Implement the Plan** during eradication Nov-Dec 2012 (4 – 6 weeks on island? less time if FWS trainees used)
6. Total required for all above

For implementation, it looks as if 1 or 2 fulltime hazers may be needed, with up to 2-3 others needed to assist in the early morning and late evening hours. We would need at least one professional hazing specialist from USDA to fill the lead role, with partner agencies likely filling the other roles as assistants when needed. While we understand that the USDA staff time requests involved may be challenging based on current staff allocations, perhaps these time commitments can be shortened by training on-island USFWS or PRBO staff to continue as the designated lead for the hazing after the first few weeks with USDA.

If total amounts for each task are difficult to estimate, perhaps daily or hourly rates you expect to bill the USFWS would suffice for now. We will of course revisit/revise any estimates if/when the partners move closer to a contract agreement and scope of work. Thanks for any timely estimates you can make, as we have to submit a budget request to fund this work this week.
