Thanks for your questions. Please see in the attached paper the definitions for database records. Incomplete eradication attempts are those that were not followed through to completion which is different than those still in progress or failed (unsuccessful) that were completed but failed to remove the population.

The database does include failed operations, if you remove the filters on eradication\_end\_date column and filter the erad\_status\_reinvaded to *failed* you will see a total of 25 failed eradication attempts (see attached), all of which are before 2007. If you remove all filters, you will see all of the records with good or satisfactory information for house mouse eradications.

See attached the list of house mouse eradication since 2007 and the Midway feasibility report. There appear to be 32 total records – 28 successful and 4 incomplete. All appeared to use brodifacoum as

the primary toxicant with one (Cocos, Guam) using brodifacoum in bait stations followed by a diphacinone hand broadcast.

Let me know if you have any questions. You can change the filters on the Eradication\_End\_Date and Erad\_Status\_Reinvaded columns to see the full list of house mouse eradications.

Hi Gregg, Heath and Richard,

I'm emailing all of you because I don't know who the proper contact is at the moment. As you probably know, we know a California Coastal Commission hearing on the Farallon restoration project coming up on July 10. I'm hoping you can help with a request from the Commission staffers.

In our Final EIS, we stated that that since 2007, 28 of the 30 house mouse island eradication projects undertaken across the globe (those with documented methods and results) have been confirmed as successful, and all but one that used a rodenticide used brodifacoum or another closely related second generation anticoagulant. Is it possible to get a list of those projects?

They're hoping I can get this to them by July 3 or so. I know that's short notice.

Thanks for anything you can do to help.
