Thanks for the support letter for the OWCN proposal. It's almost perfect as is, but because USGS has said they would not use their UAVs for hazing, and we are not sure yet if we can use other people's UAVs for hazing, it might be best to stress the our (suggested verbage:) **"Use of UAVs will primarily be for visually monitoring where seabirds and MM are, and that the hazing will be done by a variety of methods. The effectiveness of using some remotely operated vehicles for actual hazing of gulls may also be tested."**

Could you make the suggested changes and re=email your letter to Rachel and I by Friday (tomorrow)? Thanks!
