Hello Matt, thanks for touching base. I heard there was quite the storm on Sunday, so really glad everyone had the ability to be on-site Saturday for initial debris assessment.

Feedback from that initial assessment indicates the debris field is extensive. Later this week TPWD game wardens will attempt to capture drone image transects of the debris field. TPWD/FWS will then meet next week to evaluate retrieval options. Since we have entered migratory bird nesting season, it is quite possible the determination will be made to forgo retrieval efforts until a later date. Expect an update on this sometime next week. Until then, please stand by and do not conduct retrieval efforts on TPWD/Refuge property. Our understanding is that nothing in the debris field poses a toxic hazard and there is no urgency for retrieval.

Let me know if there are other considerations we should be aware of when evaluating retrieval timelines. Also, happy to visit by phone if helpful.
