1. Page 14. The ablation is from the plume contacting the stainless-steel **plumate** comprised of chromium, nickel, and iron, not a chemical reaction from the vehicle (FAA 2023)

ICF comment: Revise to "plate".

FWS response: Will revise. The word was changed by FAA reviewer to plumate on first review.

If FAA sent that prior comment it was in error.

2. Page 18-19 Reasonable and Prudent measures missing #3.

ICF Comment: Terms and conditions mention there are 3 R&Ps but only 2 show.

FWS Response: R&Ps should read:

1. The Service believes the following.....recommendations for corrective actions (if any) will be reported to the Service, as outlined in the monitoring plan once it is developed.
2. FAA and SpaceX will coordinate with the Service to review and update all plans, in particular the Biological Monitoring Plan outlined in the May 12, 2022, BCO as needed. Reviews will focus on needed updates of survey methods, their effectiveness in tracking take issued in the 2022 BCO, and potential remediation solutions if needed.
3. FAA will make implementation of the voluntary conservation measures listed on page 7 as well as reasonable and prudent measures listed above and, in the Terms and

Conditions section of this document, a condition of its launch license, such that SpaceX is required to implement all the Terms and Conditions of the 2022 BCO and this 2023 Addendum #1.

3. Page 20 Monitoring and Reporting Requirements

ICF comment 33739: Missing the requested "SpaceX will"..FAA previously requested it sate: "Upon locating a dead, injured, or sick listed specis on refuge lands SpaceX will contact Refuge"
