Jim - I hope you are well. Please look over what David Newstead has submitted to us regarding SpaceX and injury to nesting birds. I know there was a change in Refuge LE folks but I am not clear on how their chain of command changed. I am not sure what a reasonable solution for this might be. I can only think of a permit with an annual compensation amount for take or making the site unsuitable for nesting birds.

I copied David on this so any ideas or direction to an appropriate staff would be helpful. I also copied Wade.
