QUALIFIED SMALL-WHORLED POGONIA SURVEYORS

The following list includes persons known by the U.S. Fish and Wildlife Service to have the skills and experience to conduct surveys for the small-whorled pogonia (*Isotria medeoloides*). Observations of the small-whorled pogonia at previously undocumented sites must be reported in writing to the Service within 48 hours. Small-whorled pogonia surveys should be overseen by a qualified surveyor, who should be present in the field at all times during the investigation.

This information is not to be construed as an endorsement of individuals or firms by the Service or any of its employees. Persons not on this list, but who have documented experience in conducting scientific studies of, or successful searches for, the small-whorled pogonia may submit their qualifications to the Service for review. The submission must include documentation that the requestor has experience successfully locating and identifying the small-whorled pogonia and its habitat. Additions to and deletions from this list are at the sole discretion of the Service. This list is subject to revision at any time without prior notice.
