Applicants must include a \$12.50 per hunter non-refundable application/hunt fee in the form of a certified check, money order, or cashier's check made payable to the U. S. Fish and Wildlife Service. Cash and personal checks are not accepted.

Up to five hunters may apply as a group on this application form and by submitting one form of payment for entire hunt party.

Permits will be mailed to applicants 2-5 at unique addresses if that box is selected; otherwise, all permits will be mailed to the primary applicant.

Youth hunters may indicate on their application that they are a youth hunter (17 and under) and their hunt period preference (Hunt 1 or Hunt 2). Only youth hunters (and those in their hunt party) may indicate a hunt period preference. This is not a guaranteed draw. If the youth party is drawn while space remains in the draw, their hunt period preference will be honored. Youth applicants must have applied for turkey tags and this information will be verified before a quota permit is issued.

Applications must be postmarked or hand delivered to the refuge office no later than **March 1, 2022.**

A random, computerized drawing will distribute hunters between the two hunt periods. Hunters may contact the refuge office after March 10, 2022 to inquire about drawing results.

(check here) Preference Point – if you were not drawn for the 2021 turkey hunt and received a preference point letter, enclose the letter with this application. The preference point will only be given to one application; the same group may apply. If group members apply separately, only one application will get a preference point. Hunters that are not successfully drawn this year will be issued a preference point (extra entry) into next year's hunt (if they apply).

All information you provide will be considered in reviewing this application. False, fictitious, or fraudulent statements or representations made in the application may be grounds for revocation of the permit and may be punishable by fine or imprisonment (18 U.S.C. 1001).

PRIVACY ACT STATEMENT

Authority: The information requested is authorized by the National Wildlife Refuge System Administration Act (16 U.S.C. 668dd-ee) as amended and the Refuge Recreation Act (16 U.S.C. 460k – 460k-4, 640K-3, & 664).

Purpose: The collection of personal information is to verify that an individual is eligible to receive a permit to conduct monitored activity on areas within the National Wildlife Refuge System, national fish hatcheries, and other conservation areas administered by the Secretary of the Interior for fish and wildlife purposes.

Routine Uses: The individual's information will be used to verify permit status, provide permittees with permit-related information, and monitor activities conducted under a permit. This information may be shared in accordance with the Privacy Act of 1974 and the routine uses listed in the System of Records Notices: FWS-5 National Wildlife Refuge Special Use Permits; FWS-21 Permits System; FWS-10 National Fish Hatchery Special Use Permits.

Disclosure: Providing the information is voluntary; however, as a requirement for maintaining a Federal permit under the National Wildlife Refuge System Administration Act, failure to disclose the requested information may be sufficient cause for revocation of the permit.

PAPERWORK REDUCTION ACT STATEMENT

We are collecting this information subject to the Paperwork Reduction Act (44 U.S.C. 3501 *et seq.*) to provide the refuge managers the information needed to decide whether or not to allow the requested use, and to respond to requests made under the Freedom of Information Act and the Privacy Act of 1974.
