Supplemental Instructions

Haying Opportunity

The U.S. Fish and Wildlife Service (Service) is seeking qualified applicants for a Cooperative Agricultural Program at the Sand Lake Wetland Management District (District) in north central South Dakota. Haying cooperators will have seasonal use of a specified WPA for a two-year period. Please familiarize yourself with the USFWS Waterfowl Production Area (WPA) that has been put forth for haying. Please review the bid prospectus for the unit before submitting your bid. To be considered for the program applicants must complete the applicable portion of the FWS Form 3-1383-C (Commercial Special Use). The applicant must address in their application how they will meet the selection criteria outlined in the instructions.

Background

Sand Lake District was created in 1961. The Sand Lake District covers eight counties in east central South Dakota. The District consists of 162 Waterfowl Production Areas (WPAs), totaling 45,000 fee owned acres, in Brown, Campbell, Edmunds, Faulk, McPherson, Potter, Spink, and Walworth counties. The topography in the eastern counties of the District is relatively flat while the western counties have both flat areas and rolling hills. The WPA's are a part of the National Wildlife Refuge System. National wildlife refuges and WPA's are vitally important to wildlife and people. These lands are managed to provide habitat for endangered species, migratory birds, and other wildlife. They also provide places for people to hunt, fish, learn about and enjoy wildlife.

The purposed haying on the District is to improve habitat conditions for migratory birds, prevent encroachment of woody vegetation on upland meadows, and reduce cover of invasive plant species. The effects of the agricultural programs were explored in depth in the Refuge Comprehensive Conservation Plane (CCP) (USFWS 2012). The plan provides management direction for grassland portions of the refuge by focusing on important groups of wildlife and their associated habitats identified in the CCP planning process. The prescriptive haying activity was determined to be a compatible use during the CCP process.

The Proposed Cooperative Agricultural Agreement

The selected applicants will operate under a Cooperative Agricultural Agreement (CAA) as "Cooperators" with the Service. Under this CAA the Service is proposing the Cooperator be responsible for haying an allotted acreage of pasture in the District with the goal of removing this years as well as previous years vegetative growth. The Cooperator will be allowed to hay from August 1 to September 1during the agreement period. A plan of operations will be developed prior to any Cooperator activity.

The District is seeking to award a CAA for the following Brown County management units:

Braun Waterfowl Production Area (WPA)—Brown County 122-64-17

You are bidding on haying this unit for a 2-year period (2022-2023). The permittee will be required to develop an annual Plan of Operations with Sand Lake District. There will be approximately 90 harvestable acres. Please see attached map.

WPA Description

The WPA is a total of 100 acres containing a combination of grasses and sedges including cool

season tame grass and limited amounts of warm season native grass species.

Unit Description

This having unit is a total of 15 acres containing a combination of grasses and sedges.

CAA Selection and Application

The Cooperator will be selected through an open and competitive process. Interested Cooperators will be evaluated based on the proposed bid (\$/acre), and experience and qualifications that demonstrate an ability to meet the resource management objectives of the District. The objective criteria that will be utilized in selection are further defined in the Supplemental Instructions in the bid packet.

All bids remain sealed and will be opened on the same day. Apparent high bidders will be notified promptly of their selection. Bids received after the closing date will be returned to the bidder unopened. Bids not in conformance with advertised terms of the sale will be rejected. The Sand Lake District reserves the right to reject any or all bids that do not meet the requirements identified in the bid prospectus. Furthermore, the Sand Lake District also reserves the right to reject bids from any bidders that have previously violated the terms of any Special Use Permits (SUP).

Winning bidders must complete a Cooperative Agricultural Agreement (CAA) with the Sand Lake District Refuge Manager within two weeks of winning bid notification, and prior to any haying on to the WPA. The CAA will include the Special Use Permit and an annual Plan of Operations.

To apply:

Your bid package must include: (1) a signed Special Conditions form; (2) a signed bid worksheet; and (3) a completed first two pages of the Commercial Activities Special Use Permit Application, USFWS Form 3-1383-C.

Special Conditions

General Operating Requirements of Haying Program:

- The USFWS reserves the right to modify or terminate the CAA if habitat conditions warrant. If changes to the permit are deemed necessary, the permittee agrees to abide by the changes or the permit will be voided. The permittee will be notified ahead of time if any such changes are implemented.
- The Refuge provides the Cooperator with access to the WPA to perform haying activities. In exchange the Cooperator utilizes labor and equipment to perform activities that help achieve District goals. Pastures will have an assessed value based on the number of harvestable acres and the accepted Cooperators bid proposal.
- Haying will occur after July 31st and be completed by September 1st each year.
- Litter and thatch will be removed from the hayed area using a rake or discbine etc.
- All hay and equipment will be removed by September 15th each year.
- All liability related to having to include all persons working for the cooperator is strictly that of the Cooperator.
- All equipment used in pasture management must be clean and free of invasive species plant material including seeds before entering the WPA.
- Haying privileges may not be sold, transferred, or sublet.
- Harvested hay must be used for the Cooperators operation and may not be sold or traded.
- Any damage to Government property must be reported to the local Refuge Manager immediately and replaced by the permittee.






Braun WPA Brown County Hay Unit Approx. 50 Hayable Acres 2022 Approx. 40 Hayable Acres 2023









Evelo WPA Brown County Hay Unit Approx. 50 Hayable Acres
