Accessible Deer Hunt – 2022 Fact Sheet

*It is anticipated this year's hunt will be run like years past (pre-COVID), but due to continually changing COVID conditions, the event may be modified. Applicants selected for the hunt will be informed about event logistics at the time of selection. Potential COVID modifications include the hunt being run as a self-sufficient hunt and/or hunters being required to find their own mentors.

*Please be advised that the FWS will be continually monitoring for changes in COVID-19 trends for the area as we get closer to October. Final event details and logistics will be shared with hunters once participants have been selected.

- The hunt will be conducted at Crane Meadows National Wildlife Refuge, October 11-12, 2022.
- The 2,000-acre refuge is located in Central Minnesota, approximately 30 miles north of St. Cloud and 8 miles southeast of Little Falls. From State Highway 10, take Morrison County 35 east five miles to refuge headquarters. The refuge features a unique sand plain wetland/upland complex with a rich mosaic of healthy sedge meadow, shallow lake, oak savanna, prairie, shrubland and forest habitats.
- Hunting will occur in the afternoon of October 11th and all day on October 12th until legal closing time. The refuge will be closed to all other hunting during this time.
- There will be a mandatory gun sight-in and orientation on the morning of October 11th.
- **For 2022, a maximum of 10 people will be allowed to hunt on the refuge.**
- If more than 10 people apply, the hunt participants will be chosen through a selection process/drawing conducted by Options Resource Center for Independent Living (OPTIONS), East Grand Forks, MN.

- Each hunter may harvest only one deer, either a buck or a doe. Hunters may use a management tag purchased prior to the start of the hunt to tag an antlerless deer.
- Hunters must possess a permanent disability severe enough to qualify for disability-related programs such as Hunt from a Vehicle Permit, Accessible Parking Placard, Waivered Home Services, any of the disability related fishing, hunting or park access permits issued by a state DNR based on one's disability, Federal Park Access Pass issued due to disability, SSI, SSDAC, SSDI, if a person has a disability without any of the aforementioned the definition of disability used by the Social Security Administration will be used as guidance. Questions about your eligibility can be directed to OPTIONS by calling 218-773-6100 or 800-726-3692.
- An assistant/mentor must accompany each person with a disability on the hunt.
- Hunters must possess a valid 2022 Minnesota Firearms Deer License (or Archery License if hunting with a bow or crossbow) to hunt on the refuge.

- Participation in this hunt does not prevent hunters from party hunting/hunting in the Deer Area of their choice during the regular Minnesota state deer seasons. Licenses should be purchased choosing their preferred season (Statewide A or Late Southeast B) and their area of choice. All 2022 MN State Deer Hunting Licenses will be honored during the Crane Meadows National Wildlife Refuge accessible deer hunt. Hunters are asked to refer to the big game regulations outlined in the 2022 Minnesota Hunting and Trapping Regulations booklet for additional information.
- The hunt is hosted by Crane Meadows National Wildlife Refuge of the United States Fish and Wildlife Service, sponsored by The Friends of Crane Meadows and community organizations and coordinated with Options Inc. and the Minnesota Department of Natural Resources. **For more information, contact Ron Beam at (320) 632-1575.**
