Please refer to attached pictures as first picture is what's installed at the Lukeville (Tucson 1 2) at one location. The following two pictures are from Douglas mockup. Where one picture replicate what's installed at Lukeville before ears are cut off. Second picture is we cut the lower portion of C-channel so that bottom of SWP could be flush with ground level. One issue is that we do have slight exposure of bollard grout at the bottom.

Please look over and let us know NLT COB 29 Aug of you and others of envisioned SWP as the Douglas is ready to install them beginning next Monday. Thank you.
