In reference to BLM managed land in the Safford Field Office we do have some BLM land involved in some of the new barrier sections, it would be that area just west of the NM border in an area identified as critical Jaguar habitat. We are in the process of putting together comments for that section to submit to CBP/USACE. We will have those comments in by the new due date of May 15.

As far as location recommendations for small wildlife openings on non-BLM managed land, we won't be providing any recommendations because of the need to provide comments or recommendations directly related to our area of jurisdiction. Thanks for checking.

On a side note, we did work with other federal partners to provide CBP/USACE a list of recommended locations for small wildlife openings to Emily Lester (USACE) back in September (attached). Can anyone provide a status update as to if those recommendations are being implemented during construction? Thank you,
