Folks,

I attached the simple break down of the Glenn Well usage numbers up to May 4, two things stood out to me.

1) As expected, usage is up quite a bit, to the tune of 440K gallons per day! As you recall this is substantially larger than 70k per day they said they would use. I recall when i blown away by 200K per day. I have not seen the latest pressure readings from the Mitigation well, but i can imagine.

2) The DHS spreadsheet that Juliette sent on this email string shows 8 different wells. I would like to know the locations of all these. A few I know, but 5 of them I do not. The question for me is, are these near other refuges or ESA species, (ie. Buenos Aires, Quito Baquito, Cabeza Prieta, etc.) and do we need to be looking into these as well as the Glenn well?
