Happy New Year! You received a draft of the BO while I was out on use-or-lose leave. Since then, we have noticed a couple of things that you should be aware of while you are reviewing the document.

1. Figure 4-4 is missing. I have attached it to this email.
2. On Page 49, line 1725: The Figure is labelled 4-2. It should be labelled 4-1. There is no reference to a Figure 4-2 in the text. The Figure numbers will be adjusted in the next version of the BO.
3. On page 278, line 10417: The Figure is labelled 17-2. It should be 17-1. Figure 17-1 is the only figure in that section.
4. On page 42, line 1428: Appendix F is referenced, but Appendix F of the dEIS should be referenced.

5. On page 125, line 4389: Appendix A is referenced, but Appendix H should be referenced.
