Angela and others: Yes, we will send the RFP and the vendor list to you prior to its release to the public. I was working with the Procurement Department yesterday, and they are using the original document that we used for the Request for Proposals for the first round, but some of the provisions in the document need to be modified to better fit the remand process that we are going through with this round of requests. Yesterday, Procurement was also cleaning up the vendor list and checking our own corporate lists to see if new vendors are in existence now that did not exist 8 or more years ago, and you should be getting the bidder's list soon to see if you have other vendors you want added.

As soon as we get the revised Request for Proposals document, we will forward that to you all also, but it will not be ready to distribution this week.

I have also asked the Procurement folks to put together a schedule of the time frame they think that this process will take from the point the proposals are sent to vendors, and FWS has selected a winning vendor.
