The U.S. Fish and Wildlife Service has completed a five-year status review for the grizzly bear in the lower 48 states and has a court ordered posting of this document and finding by March 31, 2021.

4. **What is the proposed date for this action? Why has it been selected? Is it flexible?**

There is a court ordered deadline of March 31, 2021 (or earlier) to post the five-year review. This date is not flexible.

SECTION II: GOALS AND MESSAGES

6. **What story do we want to tell?**

The U.S. Fish and Wildlife Service has completed a five-year status review of the grizzly bear in the lower-48 states. The recommendation of no change to the current ESA listing of threatened has been made following a thorough review of the best available science,

informed by a peer-reviewed species status assessment. Although there are indications that grizzly bear populations in the Northern Continental Divide and Greater Yellowstone ecosystems are biologically recovered, this five-year review is an analysis of grizzly bears in the lower-48 states as a single listed entity. Partnerships with local, state, Tribal and federal agencies have been vital to successful efforts to conserve grizzly bears to date, and they will continue to be important in addressing challenges to fully recovering the species.

- The U.S. Fish and Wildlife Service is announcing the completion of a five-year status review for the grizzly bear in the lower 48 states [\[link to doc\]](#) and is recommending no change to the current listed status of threatened under the Endangered Species Act. This recommendation follows a thorough review of the best available science informed by an independently peer-reviewed species status assessment [\[SSA link\]](#).
- The grizzly bear is listed under the ESA as a single entity in the lower 48 states. As such, the five-year analysis and recommendation of no change to grizzly bears' status in the lower 48 states is made to the listed species as a whole. Although populations in certain ecosystems may be recovered, they are not individually listed entities under the ESA that necessitate separate five-year reviews
- The ESA requires the Service to complete a review of listed species every five years, to determine whether it is receiving the appropriate level of protection. The five-year status review is informed by a peer-reviewed species status assessment, which includes the best available scientific information. The assessment evaluated the species' current needs, conditions and threats and models future scenarios. This analysis involved significant contributions from scientific experts, including an independent peer review as well as review by partners at federal, state and Tribal agencies.
- Progress toward recovering the species has been made through close partnerships with local, state, federal and Tribal agencies since the original listing in 1975. This work among recovery partners is a significant factor in the species not being listed as endangered. However, considerable challenges remain to fully recovering the grizzly bear in the lower 48 states, resulting in the recommendation to continue their threatened status. These remaining challenges include limited habitat connectivity, management of motorized access, human-caused mortality and uncertainty surrounding future conservation efforts. The Service looks forward to continuing grizzly bear conservation work with partners at local, state, Tribal and federal agencies to fully recover the species.

A recent review of the best available science indicates grizzly bears should remain protected as threatened under the federal Endangered Species Act (ESA) in the lower 48 states: [\[link to short URL\]](#) The latest science also indicates grizzly bear populations in the Northern Continental Divide and Greater Yellowstone ecosystems in the American West are biologically recovered, indicating important progress in grizzly bear conservation.

Grizzly bears are currently protected across the entire lower 48 states since grizzly bears are currently listed as a single entity under the ESA. The ESA indicates that 5-year status reviews must evaluate the status of protected species, including grizzly bears, as currently listed to ensure an appropriate level of protection. For this reason, even as some populations demonstrate biological recovery, they remain protected as threatened.

Partnerships with local, state, tribal, and federal agencies remain critical to ongoing grizzly bear recovery. We're committed to working with public and private partners to ensure grizzly bears continue enduring in the wild for future generations, while also ensuring safety for people and bears by reducing human-bear interactions.

Additional info from internal memo:

- Although conservation efforts have improved the condition of the grizzly bear in the lower-48 States since its listing in 1975, our assessment of the entire listed entity's condition 30 to 45 years into the future indicates that the grizzly bear in the lower-48 States continues to meet the Act's definition of a threatened species.

- We solicited data for this 5-year status review, and the associated SSA report, from interested parties through a January 14, 2020, Federal Register notice announcing this review. A variety of partners contributed to the development of our SSA; the SSA report was also reviewed by partners and independently peer reviewed.
- This 5-year status review fulfills our obligations under the Act and a court-ordered settlement agreement to review the status of the grizzly bear in the lower-48 States. To meet the court-stipulated agreement, we must post this 5-year status review to our websites by March 31, 2021.
