Hi all,

I hope you are all safe and well. Given the current situation, we will be holding this RTM remotely. As such, we are updating the calendar hold to more accurately reflect the times during which we will meet (since we do not need to plan for travel days). During our Recommendation Team Meeting, decision-makers will, based on the information in the grizzly bear Species Status Assessment (SSA), come to consensus on the status recommendations to present in the grizzly bear five-year review.
