I just heard from LR6 that they intend to post the grizzly bear 5-year review and SSA on their website this Wednesday (will forward the link when I get it). The 5-year review recommends no change in status (i.e., grizzly bears in the lower 48 remain Threatened under the ESA). The 5-year review does not attempt to examine the validity or status of possible Distinct Population Segments.
