Folks:

As per the Anomaly Response Plan, I wanted to let you know that SpaceX has initiated the anomaly response plan to address the debris from this launch. As soon as the area is safe to enter, I expect to tour the site to assess post-launch impacts. I don't expect debris from the ship/booster since it was aborted off the coast but the launch itself expelled lots of debris and started a grass fire. Camera equipment and vehicles left across the highway were significantly damaged and pieces strewn about. Let me know if you need anything else.
