Hi Micah! Our staff will be going in to assess as soon as the road closure ends. The last update I received about an hour ago said they expect that will be late today. After refuge staff have completed the assessment I will work with them to get a summary drafted for media release and will send it up to USFWS headquarters and DOI for approval. Once we have that approved by leadership I can send it out to reporters. At this point without knowing exactly when the closure will end, or how long it will take staff to complete the assessment, I can't give a great answer on when we will be able to release any information.

Info on Lower Rio Grande Valley National Wildlife Refuge:

- The Service protects more than 110,000 acres of habitat in the South Texas Refuge Complex, which includes the Lower Rio Grande Valley National Wildlife Refuge managed lands and public beach adjacent to the SpaceX facility in South Texas.
- Boca Chica State Park, fronting on the Gulf of Mexico just 3 miles north of the mouth of the Rio Grande, was acquired by the Texas Parks and Wildlife Department (TPWD) in 1994, and consists of a number of tracts totaling 1,056 acres of dunes,

flats, marshes, and coastal grasslands. TPWD's lands have been managed by the U.S. Fish and Wildlife Service (Service) as a component of the Lower Rio Grande Valley National Wildlife Refuge since 2007 under the terms of a 50-year lease.
