The United States Fish and Wildlife Service (FWS) Freedom of Information Act (FOIA) office received your request dated October 2, 2023 and assigned it tracking number DOI-FWS-2024-000006. Any and all written correspondence, including photographs, calendar invitations and meetings, to or from the Fish and Wildlife Service and representatives of SpaceX and/or the FAA that mentions the words "deluge system" and/or "pygmy owl." To narrow this request so that it is not a burden on your staff, I am only seeking records from the month of September, 2023.

Response

We writing to respond to your request. We have identified six documents (138 pages) responsive to your request which are being released to you in their entirety. We will send you a File Share link to access these documents in a separate email.

In addition, we have located and referred five records that primarily concern the Federal Aviation Administration (FAA), a Federal Government Agency that is also subject to FOIA.
