Rebecca and I have gone about as far as we can go on this - the proposal for appending new approaches on demographic criteria both to the recovery plan and to the CS. We need you to look at the step down protocol for the application of these new approaches on pp. 7-8 of the attached document describing the proposed new criteria.
