Michael: Assuming we can get these two elements into final today, we will be willing to support the Conservation Strategy:

RE the FWS Memo: We have one sentence to propose -- near the end of the third paragraph. It would add: Even if a new population estimator is developed and implemented, Chao2 will continue to be used to determine discretionary mortality.

This is consistent with our concern about not growing bears by math which would increase the potential harvest.

RE the Wyoming letter, Sue and Dan offer the suggestions below. I agree with Sue's comment about signature. Leaving out the Regional Director is not acceptable. So we either all three sign, Sue and I sign, or just I sign.
