Thank you Jennifer for the clean copy. Not hearing any significant opposition to the proposal on the table, my recommendation is that everyone give the attached proposal one last review, and then we send a final recommended draft to the YES committee. I did make a couple of suggested edits for consideration. The main one is an attempt to try and include some perspective on why a revision might be helpful - that addressing the increased visitor use in a planned and managed way is actually better for bears than that increased visitation resulting in more dispersed, unmanaged use of higher priority bear habitat. If this is problematic or can be said better, please say so.

Please review and get any final edits to me by Friday, Sept. 16 (including if you don't like my suggested wording).

I don't think we need another call unless someone has significant heartburn with the proposal. I recommend we include the timeline in what gets submitted to YES, and let them decide whether or not they want it included in the Conservation Strategy document, as well as make a formal recommendation that this topic, and progress on completion of the review and revision be a standing agenda item on the YES agenda until it is completed.

We can start working on the revision language at any time, and can convene a call to address Lisa's concerns about getting the right people assigned in the near future.
