As per our conference call today, following are my comments/edit/suggestions for changes to the CS document:

\*A detailed map of the DMA or a link to it on the FWS's web site for the public to be able to accurately assess exactly where the DMA boundaries are (especially where it impacts private land). I would suggest it could be added as the last section of "table of contents" along with a reference in the executive summary where to find it. Maybe on page 1 as a footnote under the DMA reference?

\*Tables: please delete Table 5--elk hunters==no longer needed

\*Executive summary: chp 3 bullet points-habitat criteria will be monitored and reported include:

#2--is the terminology correct? drop carcasses, only ungulate?

#3-delete monitoring of elk hunters

\*executive summary, chp 6:

5th bullet: implement review as necessary and "submit a petition for relisting" --is that the correct verbiage?

6th bullet: appoint chair to I&E--correct?

last sentence before "petition for relisting"--will the YGCC petition the FWS for relisting??

\*Chp 1:

Figure 1 has two maps-which one is to be used? - one has YNP and the other National park land (not defined yet)

\*Chp 2:

Figure 3 table should have "cubs of year" on one axis (did we drop actual count of Fcoy on that table?)

Figure 3 second table --why necessary when we dropped the "outside" of the DMA from the explanation?

Last paragraph of chp 2: on genetic monitoring protocol: "All monitoring protocol and be conducted and funded by those agencies assigned to that area of responsibility". Could use similar wording in other places to make it clear. Perhaps be added to the executive summary for clarity.

Chp 3:

\*Figure 6: does not have DMA shown--should it??

\*Activities allowed in secure habitat: I am still struggling with the 3rd bullet point where it indicates that over the snow is allowed "unless new research identifies a "concern"". I believe its too vague--would a better term be "threat".

\*monitoring protocol for ungulates: annual estimates have been made since "\_\_\_\_" needs to be filled in.

\*figure 8 has two maps--which one is the final version?

Chp 4:

\*management authorities uses all three, YNP, GTNP and JDRP but the last sentence uses the term "national parklands". should we use that term in all places or identify each separately? The next several pages uses both. Should be consistent.

\*The last sentence before "conflict bear standards" indicates "the following conflict grizzly bear standards apply only to the PCA and national parklands" with no list following. The next paragraph talks about inside and outside the PCA. It appears that the entire sentence could be deleted as there is no list following that sentence.

Chp 6:

\*second para-after "super-majority" insert "2/3" in parends

\*typo: "minimu" should be minimum in that same paragraph

\*primary activities of the YGCC are: last bullet point deleted about appointing chair members of I&E. Later I&E team responsibilities are fleshed out--does the reader assume the present I&E continues under the YGCC?

Great job on the CS document!!!
