Our charge: for each of the themes identified in the attached,

- 3) Review each theme and report back to the steering committee by May 25th with a recommendation on whether each theme is appropriate for the conservation strategy and the approximate amount of time it may take to address the issue. Please have your chair person report by e-mail to the Steering Committee. Your evaluation criteria should focus on:
 - a. Is this theme necessary to update the conservation strategy based on changes that have occurred in the science or delisting framework or to improve the strategy?
 - b. Is this item relevant to the Conservation Strategy or should it be addressed somewhere else?

I encourage each of you to review the habitat chapter in the Conservation Strategy in order to prepare for this meeting and to be able to answer the above questions.
