First off, I want to thank those of you who made time for me to visit with you about the upcoming meeting in Denver. I will keep trying to reach those of you I have not yet. Richard and Jeff (G), please provide a phone number that I can use to reach you.

As facilitator for the meeting, I have drafted up the attached agenda, which is fairly self-explanatory. My goal is to help both the FWS and the states clear up misunderstandings and communication gaps that are evident to me, having spoken with most of you, and to help you seek resolution of the issues that currently divide you.
