Subject: Follow up to GYE grizzly bear discussion

Andrew -- Dan mentioned that you had contacted him recently about our late February meeting on grizzly bears and asked me to follow up with you.

If would be most helpful for us to continue this dialogue if you and your colleagues could commit to writing by the end of the month your 4-6 most significant issues/concerns. One-pagers describing each issue and the actions or commitments you would suggest to address your concern would help us work through the issues and communicate clearly.

We would anticipate that the next step would be a call next month to ask questions or seek clarification on anything presented in your issue papers, and to discuss a path forward.

We also think that there would be value in broadening the discussion to include the affected state fish and wildlife agency directors. One possibility would be a meeting in conjunction with the summer meeting of the Western Association of Fish and Wildlife Agencies, which will be in San Antonio from July 17-23. Please let us know if you agree that it might be useful to have a discussion with the states.
