Under NEPA (42 U.S.C. 4321 et seq.), we announce that we intend to gather information necessary to prepare a dEIS on the draft ECMSHCP under the Act (16 U.S.C.

1531 et seq.). The Department of the Army, Corps of Engineers is a cooperating agency in the development of the dEIS.

## Background

Section 9 of the Act and Federal regulations prohibit the "take" of wildlife species listed as endangered or threatened (16 U.S.C. 1538). The Act defines the term "take" as to harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect listed species, or to attempt to engage in such conduct (16 U.S.C. 1532(19)). Harm includes significant habitat modification or degradation that actually kills or injures listed wildlife by significantly impairing essential behavioral patterns, including breeding, feeding, and sheltering [50 C.F.R. 17.3]. Under section 10(a)(1)(B) of the Act, the Service may issue permits to authorize "incidental take" of listed species. "Incidental Take" is defined by the Act as take that is incidental to, and not the purpose of, carrying out an otherwise lawful activity. Regulations governing permits for threatened species and endangered species, respectively, are in the Code of Federal Regulations (C.F.R.) at 50 C.F.R. 17.32 and 50 C.F.R. 17.22. All species included on an incidental take permit would receive assurances under the Service's "No Surprises" regulations [50 C.F.R. 17.22(b)(5) and 17.32(b)(5)].

## **Proposed ECMSHCP**

The proposed incidental take permit associated with the ECMSHCP would authorize take that may incidentally result from certain otherwise lawful actions, such as

private development, within the ECMSHCP area, provided that the permit holders implement the ECMSHCP and comply with incidental take permit (ITP) terms and conditions, including those related to the assembly and management of coordinated ECMSHCP mitigation areas. Specifically, the activities for which incidental take would be authorized ("covered activities") would include residential and commercial development and earth mining. The ECMSHCP would develop a program of take avoidance, minimization, and mitigation, with an emphasis on preservation of remaining natural lands that will aid in supporting viable populations and the continued existence of federally listed threatened or endangered species, as well as several species that are not currently federally listed (described below). The ECMSHCP creates a plan for protecting federally listed threatened or endangered species, and other species, while accommodating the productive use and development of private land in the ECMSHCP area. The ECMSHCP also includes a funding mechanism for additional conservation actions, such as land acquisition, habitat mitigation, establishment of wildlife crossings, ecological restoration, land management, and actions to assist in the conservation of species through research.

The proposed term of the ITP associated with the ECMSHCP, as requested by the applicants, is 50 years. The ITP would authorize the incidental take of threatened and endangered species that would occur as a result of the covered activities.

Species proposed for coverage in the ECMSHCP and ITP include species that are currently listed as federally threatened or endangered, or have the potential to become listed during the life of the ITP, and have some likelihood to occur within the project

area. Should any of the federally unlisted covered wildlife species become listed under the Act during the term of the permit, take authorization for those species would become effective upon listing. The following federally listed species are known to occur or may occur within the ECMSHCP area and would be included as covered species under the ECMSHCP and ITP: Florida scrub-jay (Aphelocoma coerulescens), Audubon's crested caracara (*Polyborus plancus*) (alternatively identified as the northern crested caracara, Caracara cheriway), wood stork (Mycteria americana), red-cockaded woodpecker (Picoides borealis), Everglade snail kite (Rostrhamus sociabilis plumbeus), eastern indigo snake (*Drymarchon corais couperi*), Florida bonneted bat (*Eumops floridanus*), and Florida panther (Puma concolor coryi). The gopher tortoise (Gopherus polyphemus), a candidate species, would also be included as a covered species. The ECMSHCP would also include the following State listed and unlisted species: Burrowing owl (Athene cunicularia); eastern diamondback rattlesnake (Crotalus adamanteus); Florida sandhill crane (Grus canadensis pratensis); Little blue heron (Egretta caerulea); Southeastern American kestrel (Falco sparverius paulus); Tricolored heron (Egretta tricolor); and the Big Cypress fox squirrel (Sciurus niger avicennia).

The proposed ECMSHCP employs a conservation strategy that would provide for preservation of a large portion of otherwise developable, privately owned lands within the ECMSHCP coverage area as habitat for the covered species, while allowing economically productive land uses in smaller, clustered parts of the ECMSHCP area. The ECMSHCP coverage area encompasses approximately 152,124 acres in northeastern Collier County, Florida, surrounding the Town of Immokalee. The area is bordered to the south by the

Florida Panther National Wildlife Refuge and Big Cypress National Preserve, to the north and east by the Okaloacoochee Slough State Forest, and to the northwest by Audubon Corkscrew Swamp Sanctuary. Biologically, the ECMSHCP focuses on the limited amount of future residential and commercial development and earth mining that could occur in the ECMSHCP coverage area (45,000 acres) away from the areas of higher value to the covered species. The coverage area is based on current scientific information on species occurrence and dispersal, and on information concerning where future development could and is otherwise likely to occur within these areas. Maintaining suitable habitat within these areas is important to ensuring the availability of corridors for species dispersal.

### **Environmental Impact Statement**

The dEIS will consider a reasonable range of alternatives, including the proposed action (i.e., the issuance of a section 10(a)(1)(B) permit under the Act), no action (no section 10 permit), variations in the scope of covered species; and variations in the location within the ECMSHCP coverage area where future residential and commercial development and earth mining could occur, or a combination of these elements. A detailed description of the proposed action and alternatives will be included in the dEIS. The dEIS will also identify potentially significant impacts on biological resources, land use, air quality, water quality, water resources, economics, and other environmental resource issues that could occur directly or indirectly with implementation of the

proposed action and alternatives. Different strategies for avoiding, minimizing, and mitigating the impacts of incidental take may also be considered.

The primary purpose of the scoping process is to identify important issues raised by the public related to the proposed action.



"Incidental Take" is defined by the Act as take that is incidental to, and not the purpose of, carrying out an otherwise lawful activity. Regulations governing permits for threatened species and endangered species, respectively, are in the Code of Federal Regulations (CFR) at 50 CFR 17.32 and 50 CFR 17.22. All species included on an incidental take permit would receive assurances under the Service's "No Surprises" regulations [50 CFR 17.22(b)(5) and 17.32(b)(5)].

## **Proposed ECMSHCP**

The ECMSHCP would result in take authorization for otherwise lawful actions, such as private development, that may incidentally take or harm animal species or their habitats within the ECMSHCP area, in exchange for the assembly and management of a coordinated ECMSHCP mitigation area. Specifically, the covered activities would include crop production, ranching and grazing, earth mining, infrastructure repair and maintenance, oil and gas exploration and production, active and passive recreation, residential and commercial development, and transportation. The ECMSHCP would develop a program of take avoidance, minimization, and mitigation, with an emphasis on preservation of remaining natural lands that will support viable populations and the continued existence of federally listed threatened or endangered species. The ECMSHCP creates a plan for complying with federally listed threatened or endangered species regulations for specified species while accommodating future growth in the ECMSHCP area. The ECMSHCP will also include land acquisition, habitat mitigation, wildlife crossings, ecological restoration, land management, and assist in the conservation of species through research.

The proposed term of the Incidental Take Permit (ITP) associated with the ECMSHCP and requested from the Service is 50 years. The ITP is needed to authorize the incidental take of threatened and endangered species that would occur as a result of the covered activities.

The following federally listed species are known to occur within the ECMSHCP area and are intended for inclusion as covered species under the ECMSHCP: Florida scrub-jay (*Aphelocoma coerulescens*), Audubon's crested caracara (*Polyborus plancus*), wood stork (*Mycteria americana*), red-cockaded woodpecker (*Picoides borealis*), Everglade snail kite (*Rostrhamus sociabilis plumbeus*), eastern indigo snake (*Drymarchon corais couperi*), Florida bonneted bat (*Eumops floridanus*), and Florida panther (*Puma concolor coryi*). The gopher tortoise (*Gopherus polyphemus*), a candidate, will also be included as a covered species.

The proposed ECMSHCP utilizes a conservation strategy that would provide for preservation of a large portion of the developable habitat for the covered species while still allowing economic growth to occur in the area. The ECMSHCP coverage area encompasses approximately 177,000 acres in northeastern Collier County, Florida, surrounding the Town of Immokalee. The area is bordered to the south by the Florida Panther National Wildlife Refuge and Big Cypress National Preserve, to the north and east by the Okaloacoochee Slough State Forest, and to the northwest by Audubon Corkscrew Swamp Sanctuary. The area is defined biologically as that area where the covered species could be affected by the proposed actions. The coverage area is based on what is currently known about movement and dispersal, and where future development could occur within these areas. It is important that suitable habitat be maintained within these areas so that barriers to dispersal do not develop.

## **Environmental Impact Statement**

The DEIS will consider a range of alternatives to the preferred alternative in the draft ECMSHCP. These alternatives may include, but are not limited to: Variations in the scope of covered activities; variations in the location, amount, and type of conservation activities; variations in permit duration; or a combination of these elements. #### **Proposed ECMSHCP**

The proposed incidental take permit associated with the ECMSHCP would authorize take that may incidentally result from certain otherwise lawful actions, such as

private development, within the ECMSHCP area, provided that the permit holders implement the ECMSHCP and comply with incidental take permit (ITP) terms and conditions, including those related to the assembly and management of coordinated ECMSHCP mitigation areas. Species proposed for coverage in the ECMSHCP and ITP include species that are currently listed as federally threatened or endangered, or have the potential to become listed during the life of the ITP, and have some likelihood to occur within the project

area. Should any of the federally unlisted covered wildlife species become listed under the Act during the term of the permit, take authorization for those species would become effective upon listing. The following federally listed species are known to occur or may occur within the ECMSHCP area and would be included as covered species under the ECMSHCP and ITP: Florida scrub-jay (Aphelocoma coerulescens), Audubon's crested caracara (*Polyborus plancus*) (alternatively identified as the northern crested caracara, Caracara cheriway), wood stork (Mycteria americana), red-cockaded woodpecker (Picoides borealis), Everglade snail kite (Rostrhamus sociabilis plumbeus), eastern indigo snake (*Drymarchon corais couperi*), Florida bonneted bat (*Eumops floridanus*), and Florida panther (Puma concolor coryi). The gopher tortoise (Gopherus polyphemus), a candidate species, would also be included as a covered species. The ECMSHCP would also include the following State listed and unlisted species: Burrowing owl (Athene cunicularia); eastern diamondback rattlesnake (Crotalus adamanteus); Florida sandhill crane (Grus canadensis pratensis); Little blue heron (Egretta caerulea); Southeastern American kestrel (Falco sparverius paulus); Tricolored heron (Egretta tricolor); and the Big Cypress fox squirrel (Sciurus niger avicennia).

The proposed ECMSHCP employs a conservation strategy that would provide for preservation of a large portion of otherwise developable, privately owned lands within the ECMSHCP coverage area as habitat for the covered species, while allowing economically productive land uses in smaller, clustered parts of the ECMSHCP area. The ECMSHCP coverage area encompasses approximately 152,124 acres in northeastern Collier County, Florida, surrounding the Town of Immokalee. The area is bordered to the south by the

Florida Panther National Wildlife Refuge and Big Cypress National Preserve, to the north and east by the Okaloacoochee Slough State Forest, and to the northwest by Audubon Corkscrew Swamp Sanctuary. Biologically, the ECMSHCP focuses on the limited amount of future residential and commercial development and earth mining that could occur in the ECMSHCP coverage area (45,000 acres) away from the areas of higher value to the covered species. The coverage area is based on current scientific information on species occurrence and dispersal, and on information concerning where future development could and is otherwise likely to occur within these areas. Maintaining suitable habitat within these areas is important to ensuring the availability of corridors for species dispersal.

#### **Environmental Impact Statement**

The dEIS will consider a reasonable range of alternatives, including the proposed action (i.e., the issuance of a section 10(a)(1)(B) permit under the Act), no action (no section 10 permit), variations in the scope of covered species; and variations in the location within the ECMSHCP coverage area where future residential and commercial development and earth mining could occur, or a combination of these elements. A detailed description of the proposed action and alternatives will be included in the dEIS. The dEIS will also identify potentially significant impacts on biological resources, land use, air quality, water quality, water resources, economics, and other environmental resource issues that could occur directly or indirectly with implementation of the

proposed action and alternatives. Different strategies for avoiding, minimizing, and mitigating the impacts of incidental take may also be considered.

The primary purpose of the scoping process is to identify important issues raised by the public related to the proposed action.

### USFWS General Comments on the draft East Collier Multiple Species HCP (9/10/2015)

- The HCP does not include a discussion of roads needed to support the proposed development. We consider roads as interrelated/interdependent activities that have to be analyzed.
- This document mentions the existing Rural Lands Stewardship Program (RLSP) but does not indicate which lands have already been protected as part of this program. Generally, the Service can't consider lands that have already been used for mitigation as mitigation for a second project unless a conservation benefit beyond what the original project provided is demonstrated. We recommend a more detailed discussion of the RLSP and how it fits into the HCP.
- The eastern panther corridor is not well located and does not appear to be wide enough to be functional. Without a functional corridor, it appears the potential east-west development in that area could block movement of panthers north and south.
- The plan allows landowners to implement avoidance and minimization measures to reduce the PHUs required to mitigate their projects. While we generally prefer avoidance and minimization of impacts before mitigating for them, options available to each landowner will be specific to the landscape location of their project and existing development in the surrounding area. Avoidance and minimization may not be possible.
- The biological goals for panthers focus on habitat goals. There should be a goal focused on actual panther use of the plan area. Otherwise, due to the landscape scale of this plan and effects to panthers beyond habitat loss as indicated by the Panther Habitat Unit calculations, it is possible to meet habitat goals but reduce panther use of the habitat to a degree that it no longer functions as it is intended.
- The plan identifies Florida Fish and Wildlife Conservation Commission (FWC) as the entity responsible for panther monitoring and indicates that the applicants will help fund the monitoring, if necessary. Has FWC been contacted about this role? How likely is it that FWC will have the funding to continue its programs? Is there an alternative plan if FWC discontinues monitoring?
- There is no adaptive management proposed for panthers (or other species) in the plan. As the main species for the plan, there should be adaptive management for panthers. It should be tied to a biological goal for panther use of the area. There is enough uncertainty about the exact types and locations of impacts that an adaptive management plan is warranted.
- The plan indicates that no incidental take of caracara will occur despite the fact that five nests and a communal roost or "gathering area" occurs in or adjacent to covered activity areas. Additional discussion is needed about take of caracara.
- Restoration for one species may not necessarily benefit another species in the mitigation area.
   For example, wetland restoration for wood storks may not be beneficial for panthers.
   Impacts associated with restoration or enhancement need to be accounted for within the mitigation area.
- There are differences between the plan and recommendations from the Panther Review Team (PRT). The Service would like to discuss alternatives that are closer to PRT recommendations.
