Re: Freedom of Information Act Request

On behalf of the League of Women Voters of Collier County (LWVCC), Florida, I request that you send us a copy of all documents, including reports, letters, emails, and any other written communications, between USFWS and the Eastern Collier Property Owners (ECPO), including their contractors and employees, concerning the Eastern Collier Habitat Conservation Plan, ECPO's application for an incidental take permit and the related environmental impact statement. I am seeking such documents for the time period January 1, 2015, to present. We are not seeking a copy of the draft 2015 Eastern Collier Habitat Conservation Plan, the application for an incidental take permit or the 2016 public comments submitted to the USFWS concerning scoping for the environmental impact statement, as all these documents are available online.

We request a fee waiver under 43 CFR 2.48. We seek the information to inform our members and community about the USFWS process concerning the ECHCP, the matters being considered by USFWS and communicated to the applicants, and the matters raised by the applicants to USFWS during this time period. Thus, disclosure of the above requested information is likely to contribute significantly to the public understanding of the USFWS action concerning the ECHCP and the related EIS. The League of Women Voters of Collier County has absolutely no commercial interest in the requested information.
