Since the meeting in Denver, the states of MT, ID, and WY have been working on a proposal for post-delisting management of grizzly bears in the GYE. Per direction from Directors Talbot, Moore, and Hagener, we would like to schedule a short conference call with you two to present to you the States' proposal. We are hoping you would be available on Thursday, March 19 at 10 am Mountain Time. The Directors will be in Denver for sage grouse meetings on March 30-31, and are inquiring with Dan Ashe about a possible face to face some time before or after the sage grouse meetings in case there are any concerns with the grizzly bear proposal, so the FWS would have several days from the conference call to the face to face to review.

So first and foremost, can you confirm if you would be available on Thursday at 10 am for a conf. call where we will present our proposal to you two?
