Noreen called me today to learn the status of our legislature on sage grouse and proposals for wolverine efforts. After those discussions she asked me where we were at with the Yellowstone grizzly delisting. I told her we had met by conference call today and will be working up a response within the next week. I told her that we were targeting May 12 or 13 that Virgil and I would run it by Dan Ashe. Noreen asked that if at all possible, could we run it by Matt and Rich prior to running it by Dan. I said the timing is pretty short (at best I said a conference call might be arranged for next Friday the 8th or Monday the 11th), but I would see if we might be able to make that happen. I will be on leave the 6 – 11, but could be on a conference call if needed. I am confident that Ken can portray the MT position, so I don't see a critical need for me to be on that call.

Is this additional call to Matt and Rich prior to the 12th feasible for others?
