Good Morning All,

Yes, in September R6 will be addressing a petition by the Alliance for the Wild Rockies to list the Cabinet-Yaak grizzly bear as endangered. Then, in November we'll be addressing a petition by Lincoln County, Montana to delist the Cabinet-Yaak grizzly bear.

I combined and tweaked our team's suggestion:

We think this is more in relation to Greater Yellowstone.

Something along the lines of....

The U.S. Fish and Wildlife Service Mountain-Prairie Region is evaluating the "threatened" status of specific populations of grizzly bears under the Endangered Species Act. One such grizzly bear population under review is in the Greater Yellowstone Ecosystem, located in Wyoming, Montana, and Idaho. There the grizzly bear population is robust and healthy. We are working with fellow federal, state, and local agencies; Tribes; and other stakeholders in this ecosystem to determine the best long-term management approach. No decision has been made, and there is no timeline established for any proposal. We have received petitions relative to other populations such as the Cabinet-Yaak grizzly bear, located further north in Montana, Idaho, and Canada. Our reviews of those actions remain in progress and no determinations have been made.

Feel free to fine tune. Happy to share more information, if you need. But, I agree, we probably need more information from the reporter before responding. We'd also be interested in when Ms. Dickie's article will publish.

Hi Vanessa,

Thank you very much for forwarding the reporter question. I've proposed to team a response along the lines of:

The U.S. Fish and Wildlife Service Mountain-Prairie Region has received a petition to delist the Cabinet-Yaak population of grizzly bears, which is located in Montana, Idaho, and Canada. Our team of biologists are reviewing the language of the petition, the best available science, and on-the-ground monitoring surveys of this specific population of grizzly bears in order to determine if its "threatened" status under the Endangered Species Act is still appropriate. We anticipate publishing our decision as a 90-day finding in the Federal Register. This decision will not impact any other population of grizzly bears.

I'll let you know as soon as I hear back.
