Dear Secretary Jewell,

We at Guardians of Our Ancestors' Legacy (GOAL) request a personal meeting with you to discuss the need for formal government-government consultation with Tribes regarding US Fish and Wildlife Service's decision to delist the Yellowstone grizzly bear population. Tribal leaders are prepared to travel to Washington, DC, for the meeting. The best dates are September 16-17, 2015.

GOAL is a diverse tribal coalition united in the common cause of protecting the sacred grizzly bear, defending tribal sovereignty, and preserving indigenous and spiritual rights. To date, 38 tribal governments have passed legal resolutions opposed to premature delisting of Yellowstone's grizzly bears, and the coalition continues to grow.

GOAL and member tribes are concerned about the dismissive and disrespectful behavior of US Fish and Wildlife Service Recovery Coordinator Chris Servheen towards the Tribes. Servheen has stated that

consultation with Tribes would not affect the decision to delist. And, he said that only three tribes have “standing” in this matter, which is clearly not the case. Tribes from the region and across the country have a legitimate stake in the fate of Yellowstone’s grizzly bears, and have made their views about delisting unequivocal with the passage of legal resolutions. Given the behavior of Servheen, we request that he not be present at this meeting.

We need not remind you of the requirements for the Department of Interior under the National Historic Preservation Act, American Indian Religious Freedom Act and numerous presidential orders to provide meaningful consultation with tribal governments.

We look forward to discussing this matter in person with you and your staff regarding meaningful consultation with all tribes concerned with the fate of the grizzly.

Please let us know if you can meet on September 16-17, and if so, at what times. If these dates are not available, please suggest alternatives, or consider our invitation for you to come to meet with Tribal leaders in the Yellowstone region.

We look forward to hearing from you as soon as possible. Please be in touch if you have any questions or would like additional clarification.
