Greetings. I would like to meet with you all next Tuesday November 4th at 11:30 a.m., **prior to the start of the YES meeting.** By all indications, this meeting will be very well-attended.

I understand that there is not a proposed delisting rule to be rolled out at this time. However, we do need to speak with one voice to address:

What is the status/timeframe/plan for a proposed rule?

What do we foresee as the role of the YES committee as this moves into a public process for a new rule?

Because we haven't said much publically yet about these points, there is quite a bit of speculation out there, evidenced by e-mails coming in, that this is the time for the public to weigh in on a delisting rule. There is also a push to add time to the public comment since some are seeing this as a public hearing of sorts.

I think that we can address all this. I will work a little with Gregg Losinski on pre-meeting messaging and I can set the tone at the beginning. But – just a good indication that we need to have a strong consistent way to address this.
